

Forum Social Mundial 2003 – World Social Forum
**The World Federalist Movement-Institute for Global Policy and the
Responsibility to Protect**

Summary Report

The World Social Forum, held in Porto Alegre, Brazil from January 23-28, 2003, offered a valuable opportunity to raise awareness of the concept of the Responsibility to Protect (R2P) amongst the more than 100,000 NGOs in attendance, to distribute the ICISS Report and other information materials, to solicit ideas regarding a potential NGO role in promoting and operationalizing the concept of R2P, and in developing an interest in future involvement in this issue.

WFM-IGP participated actively in the Forum, organizing a seminar on the Responsibility to Protect, raising the issue and mentioning the ICISS Report from the floor at as many seminars, panels and workshops as possible, and distributing both the ICISS Report and WFM-IGP materials on the Responsibility to Protect in four languages. Many important contacts were made, in particular with Latin American NGOs, and the commitment of major human rights organizations such as Human Rights Watch, Amnesty International and the Fédération Internationale des Ligues des Droits de l'Homme to be involved in this effort was significantly strengthened.

WFM-IGP accomplished the following during the four days of our attendance:

- 300 copies, including 100 in English, French and Spanish, of the ICISS Report
- 4,000 copies, including 1,000 in English, French, Spanish and Portuguese, of a 3-page overview of the Responsibility to Protect, explaining the key issues, highlighting the ICISS Report, emphasizing the need for NGO engagement in these issues and inviting communication with WFM-IGP (a sample in English and Portuguese is attached)
- 4,000 copies, including 1,000 in English, French, Spanish and Portuguese, of a flyer advertising the WFM-IGP seminar on the Responsibility to Protect, with additional copies posted in highly visible areas at the Forum
